

Appendix 3C – Plates



Plate 1 – Looking north across Field 6. The hedge to the right marks the trackway separating Area 1 from Area 2. The modern dwelling and outbuildings are directly off Wood Lane, which runs across the centre of the image.

Plate 5-Area in the eastern corner of Field 5. Historic mapping indicates a well was within this area.

Plate 7 – Looking northwest across Area 2 from the southwest boundary towards Field 7.



Plate 8 – Looking west from the corner of Field 11. Beyond the hedge to the right is a footpath that continues to Wood Lane, the start of which is indicated by the trees at the top-right of the image.





Plate 9 – The Cuckoo Bush round barrow (M22) outside the Application Site, on the other side of Wood Lane, northeast of Area 2.



Plate 10 – Looking towards the fields of Area B from the Cuckoo Bush round barrow (M22).





Plate 11 – The entrance to the Cuckoo Bush round barrow site from Field 10 and Wood Lane.



Plate 12 – Looking southeast along the proposed cable route. The opening onto Area 3 is just discernible in the centre of the image.





Plate 13 – Looking south across Field 12 from the exit point of the current proposed cable route between Areas 2 and 3. The dwelling in the centre of the picture lies slightly outside the Application Site boundary.



Plate 14 – Looking southeast towards the strip of woodland between Areas 3 and 4. The difference in ground level from Area 4 is evident.





Plate 15 - Looking north across Area 3/Field 13 where the ground level starts to slope down to the west.



Plate 16 – Looking southeast along Field 15. Rushcliffe Golf course is to the left beyond the hedge boundary.





Plate 17 – Looking north from Stocking Lane.



Plate 18 - Looking southeast across Rushcliffe Golf course from a point approximately the same as in Plate 16 on the north side of the hedges and trees lining the site. The moated site is somewhere within the wooded area to the left of the image down the slope.





Plate 19 – Southern connecting path between areas of woodland on Fox Hill from Area 4 into Area 3.



Plate 20 – Looking towards Gotham from elevated land within Field 5. There are occasional views from this field, but to the south the views are obscured by the woodlands. The old school building NA18 on the edge of the village is just visible in the centre of the image, as is the church spire for NA13.





Plate 21 – Looking towards Area 1 from the entrance to Gotham, close to the Old School Building NA18.



Plate 22 – Looking towards Area 2, which is behind the thick woodlands in the centre background, from close to the church in the historic core of Gotham.





Plate 23 – Looking south towards the historic core of East Leake from Stocking Lane and Field 15.



Plate 24 – Looking north towards the Site from the churchyard of NA14 within the historic core of East Leake. The area containing the designated assets is largely surrounded by modern development.





Plate 25 – Looking northeast towards Area 4 from just beyond the eastern end of Main Street at West Leake.



Plate 26 - Looking towards West Leake from the centre of Area 3 (Field 13), showing it to be completely screened by the woodlands to the south and southeast.





Plate 27 – Looking north from Dark Lane to the northwest of West Leake. Area 1 is behind the main patch of woodland in the background. The small gap in the trees to the right of the ridge marks the lane running between Area 1 and 2. The rising ground to the right provides an additional screen.



Plate 28 – Looking northeast towards Area 1 and 2 from West Leake Lane adjacent to Kingston Fields Farm.





Plate 29 - From the same point as Plate 28, looking east towards Areas 3 and 4.
