- A resident in Rushcliffe Borough
- Competing in a Sport England recognised sport
- Aged 14 and over on the date of application

- A letter or email direct from your National Governing Body confirming involvement at national level (please note web links will not be accepted as evidence but may be submitted as additional supporting information)
- Photograph
