This is a small farm park with reptiles and 2 flying bird collections (1 of which is currently externally managed but about to become subsumed into the main collection)

There were several errors on the PIA and changes of staff since completion and since the last inspection. There have also been staff changes at the Local Authority and it appears the informal annual inspections have not been carried out.

A new manager and a zoo consultant (the latter only the week before the inspection) have recently been engaged and improvements to policies, procedures and compliance against the ZLA/SSSMZP expectations are anticipated.

The last formal inspection was 2021, Zoo Licence issued 2020, expires 2026

The Local Authority is reminded of its obligation to conduct annual informal inspections and to coordinate with the Operator to ensure the Formal Inspections (by SoS appointed Zoo Inspector via APHA) are carried out

A number of Conditions were applied to the last licence; a number of Directions have previously been issued many of which are still non-compliant and will be repeated here; the Zoo Operator and Local Authority are reminded to familiarise themselves with the ZLA/SSSMZP requirements.

The current dispensation appears appropriate.

NOTE: This inspection report is written as per the instructions found in the current version of the 'Guidance for zoo inspectors 2019' which was released on the 21st January 2019 and clarifies that where there has been any, however small, failure of compliance that a question is marked 'no'. Where a box is marked 'no' the specific area of non-compliance is commented on and all other aspects of the zoo inspected with regard to each individual question were considered compliant unless otherwise stated. The appointment of a new senior manager who is keen on raising standards and has appointed a Zoo Consultant (only the week before the inspection) are welcome advances and auger well for future improvements although there are a number of issues raised in this report resulting in 19 Conditions and 18 Directions in this report along with 10 Recommendations.

Recommendations – 10 total

1. Dry feed is stored well in rodent proof bins in original feed sacks but advised Dry feed bags should be labelled with the date that the bag was opened.
2. It is recommended that a documented stock rotation system is used for all food items especially the frozen feed, coming onto the site to ensure best practice is followed and older food is used first.
3. The electrical supply within the reptile housing areas in the keeper areas are of a normal domestic type rather than the more commonly seen waterproof socket versions. This arrangement should be reviewed by a suitably qualified electrician.
4. In line with 10.6 of the SSSMZP 10.6 The zoo operator does make every effort to ensure that their staff do not have any convictions under the Zoo Licensing Act 1981 or under any other animal welfare or conservation legislation including that listed in Appendix 9 however an addition to ensure staff report any changes is also required
5. Consideration to the preparation of a planned preventative maintenance schedule is recommended in line with ZLA and SSSMZP expectations.
6. Veterinary clinical notes should clearly show which animal has been treated and include medication batch numbers and expiry dates. Adding times that animals are noted to have any sickness and when the vet is called is recommended
7. A medicines policy is recommended to include records, storage, use and disposal of medicines on site.
8. A contingency plan, for the event of zoo closure to include how animals would be cared for and potential rehoming of animals, is recommended to be produced and agreed with the local authority
9. Data loggers are recommended for general use around the site and especially for refrigeration units and reptile environmental parameter data monitoring to give 24hr readings
10. The bird of prey and owl flying protocols and daily management systems are currently different as one is managed by outside contractors. It is recommendation that the systems are reviewed and best practice implemented across both sets of animals.

## Additional Conditions (if appropriate)

Conditions – 19 total

1. To comply with 2.6 SSSMZZP, must provide documented evidence demonstrating the annual servicing, maintenance and checks in place that ensure that back-up life support resources are effective and functional as and when require including testing of the generator for example to retain reptile temperatures. The zoo licence holder must ensure this change has been completed within 3 months from the date on which this condition takes effect.
2. To comply with 12.1 of the SSSMZZP 2012, the current zoo licence or a copy of it, including all the conditions, must be displayed at each public entrance of the zoo The zoo licence holder must ensure this change has been completed within 1 month from the date on which this condition takes effect.
3. In order to comply with Section 10.4 and 10.5 of the SSSMZZP (2012), the zoo licence holder must ensure that there is continuous, documented in-house training of staff to ensure that they are fully competent for their individual responsibilities, that structured induction training is in place (including appropriate zoosoonos training) and that all staff are aware of their health and safety, as well as animal husbandry, responsibilities as members of the zoo team. The zoo licence holder must ensure this change has been completed within 3 months from the date on which this condition takes effect.
4. In order to comply with Section 10.4 and 10.5 of the SSSMZZP (2012), to review the staff training and various zoo procural documentation to ensure consistency and use of all relevant documents in induction and training of staff. The Review to include a cohesive and coordinated approach to the Risk Assessments, SOPs and SWPs and induction sign off per species and per member of staff. As part of this trainee staff must have a documented process of training and are signed off to the relevant procedures before being given lone worker or primary key holder responsibilities. The zoo licence holder must ensure this change has been completed within three months from the date on which this condition takes effect. The zoo licence holder must ensure this change has been completed within 3 months from the date on which this condition takes effect.
5. To comply with as per 4.3 of the SSSMZZP (2012) The zoo must ensure that husbandry programmes, including enrichment policy, provide for the psychological needs of the animals within the collection, for all species. The zoo licence holder must ensure this change has been completed within 3 months from the date on which this condition takes effect.
6. In order to comply with Section 2.1 of the SSSMZZP (2012), the zoo licence holder must review the humidity provision to ensure that species suitable levels are maintained for the reptiles OR demonstration that no additional increases in humidity are required. If humidity levels are not considered appropriate for the animals then a system must be installed that is designed for maintaining humidity levels in the vivaria and this replaces the now defunct home-made guttering-hand drier system previously employed. The zoo licence holder must ensure this change has been completed within one month from the date on which this condition takes effect.
7. In order to comply with Section 1.3d of the SSSMZZP dedicated staff hand-washing facilities must be provided where food is prepared and handled. The zoo licence holder must ensure this change has been completed within 6 months from the date on which this condition takes effect.
8. In order to comply with Section 1.3c of the SSSMZZP (2012) The floor and bottom 15cm of all walls and standing structures within all food preparation areas must be made impervious, hygienic and cleanable. The zoo licence holder must ensure this change has been completed within 3 months from the date on which this condition takes effect.
9. A documented maintenance audit process must be devised and implemented that ensures senior staff review the whole site on a minimum of a monthly basis to ensure that any defects, health and safety risks to the public or animals, or other infrastructure or maintenance needs are identified, a process of rectifying the noted problem is implemented and that the works are reviewed in a documented fashion to ensure the safety of both the public and the animals on the site as per section 8.9, 8.13, 8.14 and 8.15 of the SSSMZZP. This condition must be met within 6 (six) months.
10. The perimeter fence must be clearly defined within a map of the licensed zoo premises and sent to the local authority. The zoo licence holder must ensure this change has been completed within 3 months from the date on which this condition takes effect.
11. In order to comply with Section 8.14 of the SSSMZZP (2012), the zoo licence holder must ensure that all stand-off barriers and fences are assessed and where repairs are required these are carried out immediately OR the area is closed to the public until fixed. This includes protruding nails or screws and broken wire fencing that may cause injury to the members of the public. The zoo licence holder must ensure this change has been completed within one week from the date on which this condition takes effect.
12. In order to comply with Section 3.9 of the SSSMZZP (2012), the zoo licence holder must ensure that a documented review is carried out that reviews the disinfectants used for cleaning animal areas or used in foot dips. This must include the deployed concentrations used in the different areas; the suitability of the disinfectant and the concentrations deployed for the intended use; the method of disposal of the disinfectant-contaminated wastewater, and that COSHH data sheets are available on site. Where concentrations or disinfectant selection is found not to be suitable then the alternative agent or concentration must be clearly demonstrated and processes put in place to ensure effective disinfectant use. A sensible position and management of foot dips is also required, lids to be added to prevent dilution by rain for example, and not to be positioned in the public area where open foot dips containing chemicals could be accessed by public including children as seen on the inspection of 7th May 2025. The zoo licence holder must ensure this document has been completed within three months from the date on which this condition takes effect.
13. Ongoing training must also be undertaken for all staff and records kept of their training in accordance with 3.9(f) and Appendix 9 of the SSSMZZP with zoonotic disease included in the induction booklet for both staff and volunteers. Evidence of this must be sent to the local authority. The zoo licence holder must ensure this document has been completed within 6 months from the date on which this condition takes effect.
14. In order to comply with Section 2.1 of the SSSMZZP (2012), the zoo licence holder must review meerkat management. Meerkats are currently kept within temporary accommodation within a bird enclosure with access to a barn with a heated area. The temperatures ranges within the meerkat housing should be reviewed and ensure appropriate for the species and a timeline established for the completion of the new permanent housing for the meerkats to the satisfaction of the Local Authority. Timeframe for report 1 month, timeline for 24/7 temperature monitoring and correction as required - immediate
15. In order to comply with Section 2.1 of the SSSMZZP (2012), the zoo licence holder must review and improve the back of house stable management or stop its use for animals. A back of house stable was presented as quarantine or isolation accommodation. This was dirty yet with no recent animal use reported, hay and straw were still present on the floor, rodent pests were evident, the drinker was broken. This facility is not to be used for animal accommodation until it is repaired. Action immediate if to be used otherwise to be cleaned and locked as a storage area only or not used at all. The zoo licence holder must ensure this has been completed within 1 month from the date on which this condition takes effect.
16. In order to comply with Section 2.1 of the SSSMZZP (2012), the zoo licence holder must review feed bin locations and security. Outside feed bins were held in an outside sheltered area that were unlocked and one had a pair of scissors inside. Access to by the public was only prevented by a rope which was easily moved or walked under including by children. This puts the feed at risk of contamination. Feed bins to be stored in locked cupboards or rooms or locked. Access to the area to be better managed to prevent public access. The zoo licence holder must ensure this has been completed within 1 month from the date on which this condition takes effect.

The local authority in England (or in Wales as the case may be) is the data controller in respect of any personal data that you provide when you complete this zoo inspection form. The information that you provide may be used by the local authority in its consideration of issuing or amending a zoo licence in accordance with the Zoo Licensing Act 1981 (ZLA). The local authority may be required to release information, including personal data and commercial information, on request under the Environmental Information Regulations 2004 (EIRs) or the Freedom of Information Act 2000 (FOIA). However, local authorities will not permit any unwarranted breach of confidentiality nor act in contravention of their obligations under the Data Protection Act 1998 (DPA).

Where the zoo, to which this inspection report applies, is owned by the local authority, the local authority must send a copy of the completed form to Defra (in accordance with section 13(2) of the ZLA) where the zoo is situated in England, or to the Welsh Government where the zoo is situated in Wales. Defra or the Welsh Government (as the case may be) may use the information contained in the form to ensure that local authorities are carrying out their duties correctly in accordance with the ZLA.

Defra and the Welsh Government are also subject to the EIRs and the FOIA and so may be required to release information, including personal data and commercial information, on request. However, as above, Defra and the Welsh Government will not permit any unwarranted breach of confidentiality nor act in contravention of their obligations under the DPA.
