Statement of Activities for 2023/24

Parish Councils are required to provide Council Tax payers with details of their budgets and any relevant background information that will assist in understanding the budget.

As everyone will be aware there has been significant financial turmoil over the past year with staff costs and utility bills rising at unprecedented rates. The Council has been shielded from the impact of rising utility bills due to favorable fixed prices contracts in place until the next financial year. These are now up for renewal and the impact has been estimated in the budget. Staff pay increases are set by the government with the current year being much larger than was budgeted for last year.

A further matter outside this Council's control is the decision by Upper Saxondale residents to break away from Radcliffe on Trent and set up their own Parish Council. This has considerably reduced the tax base for this parish for next year and thus has reduced the expected income from the precept. Upper Saxondale Parish Council is entitled to a share of the combined parishes Reserves which was not considered in the current year budget but will have a significant impact on the Free Reserves of this parish.

The Council has agreed an increase in precept of 5% which is in line with the Government's upper limit for larger councils. This will generate a precept income of £312,852, approximately £16,000 less than the current year.

The combined affect of a lower precept and considerably higher costs means that there will be a deficit budget for next year. The Council is reviewing operations before finalizing the budget by department for income and costs next month with a view to reducing the deficit if possible.

Committees can spend within their net budget without further approval from Finance and General Purposes which enables the day to day operation of the Council. The correct allocation is therefore very important and once approved in February or March it will be published on the Council website.

The Council has Free Reserves (available for use), Designated Reserves (established for various projects but not fixed) and Restricted Reserves (can only be used for the purpose for which it was created). Again the situation with these is uncertain during negotiations with Upper Saxondale.

The Council employs 4 part-time Office Staff, 2 part-time Grounds Staff, 3 part-time Caretakers for Grange Hall, The Grange and the Public Toilets and part-time Hall Duty Officers for events.

The Grange and Grange Hall attract a wide range of bookings which have recovered after the COVID restrictions. Events include Civil Weddings, Funeral Receptions and Birthday Parties, Concerts, Dances and Drama, Fitness Classes, Exhibitions and Training Seminars and a wide range of Educational Classes with both venues offering Wi-Fi and media facilities.
